- Added the new Portland Metro Tax: Metro Supportive Housing Services Tax based on the requirements set by the state of Oregon:
 - A 1% marginal personal income tax on taxable income above \$125,000 for individuals and \$200,000 for those filing jointly.

- The tax jurisdiction of XORP19282 has been added by TempWorks Software for all Zip Codes directly related to the city of Portland, OR. Therefore, any employee on assignment with a worksite that has a Zip Code in Portland, OR will have the tax automatically applied as long as the above requirement has been met.
