Beyond - WOTC Charm

- The state of the WOTC charm depends on the pre-existing "WOTC Eligibility Status" field and its status via Employee > Details > Hiring > "WOTC Eligibility Status".
- Shows the WOTC eligibility status of the employee depending on the color of the charm:
 - If **black**, the employee does not have a WOTC eligibility status selected.
 - If green, the employee has one of the following WOTC statuses:
 - "Eligible"
 - "Eligible Maximized Credit"
 - "Eligible State Certified"
 - If red, the employee is not WOTC eligible.
