Additional Updates

In Beyond

- Fixed an issue where E-Verify cases were unable to be continued.
- Fixed an error when attempting to change an E-Verify password.
- Fixed an issue where a message would not be pinned after selecting to pin the message.

- Fixed an issue where the “Action Type” dropdown would be empty when attempting to filter messages on any record type.
- Fixed a “Report Cannot Be Found” error that would occur when attempting to run reports within Beyond.

In Enterprise

- Fixed a visual issue where hierarchy nodes would not appear within the hierarchy list.

In HRCenter

- Updated the Puerto Rico W4 to the latest version.
- Updated the mobile friendly Federal W4 form to the latest version.
- Fixed an issue where the employee phone field would not be formatted correctly within custom email templates.

- Added Lansdowne Borough, PA tax jurisdiction “XPAL25617” to the Zip Code of 19050 at a rate of 0.5%.
- Fixed tax jurisdiction issues related to Elkland Borough, PA and Elkland Township, PA:
 - Elkland Borough, PA is now jurisdiction “XPAE751574” for Zip Code 16920.
 - Elkland Township, PA is now Jurisdiction “XPAE51574” for Zip Code 18616.
