## The Highlights



### **Beyond UI/UX Enhancements**

The following updates have been made to the Beyond UI/UX based on user feedback:

- Added an underline to all text links.
- Implemented additional theme options.
- The Favorites menu (Beyond > Search > Favorites (Star)) state is now saved, making it so
  users can quickly navigate back to their last tab.
  - Previously when opening the Favorites menu, it would default to the "Employee" tab.
     Now when opening the Favorites menu, it will open to the last record tab you had navigated to.

#### In Beyond

- Fixed a timeout error that would be received when attempting to load the Candidates list.
- Fixed an issue where Interest Code Categories would not match between Beyond and Enterprise.
- Fixed an issue preventing the enrollment of Rapid! PayCard Instant Funding when an employee has an SSN beginning with zeroes.

#### In WebCenter

• Fixed an issue where WebCenter notification would be sent to inactive contacts.
