Welcome to the new year! This release brings tax updates along with additional fixes across TempWorks products.

### **Additional Updates**

#### **Beyond**

- Removed a browser alert when assigning Job Order Candidates.
- Fixed an error that would occur when an Advanced Search yields no results.
- Fixed an issue preventing the adding of reference questions within System Settings.
- Fixed a timeout error that would occur when completing a proofing session within Beyond.
- Fixed an error that would occur when navigating to the Hierarchy tree within Beyond on a mobile device.
- Fixed an issue preventing the enrolling of a Rapid! Paycard for employees with a Zip Code that starts with a "0".
- Fixed an issue where inactive Customer records would appear when creating a Job Order record via Quick Add.

#### Reports

- Fixed an issue preventing the Payroll Summary report from functioning as intended within Beyond when running the report during monthly durations.
- Fixed an issue within the Sales Pipeline report when selecting "All Reps" where the report will break out every rep instead of combining them into one line item for "all reps".

#### WebCenter

- Fixed an error that would occur when attempting to upload documents to WebCenter timecards.
- Fixed a visual issue where, before submitting, WebCenter timecards could show within multiple week endings.

#### **Tax Updates**

- Created additional checks (Assignment Restriction and Proofing Error) for employees missing Maryland county taxes when applicable.
- Completed the following tax updates:
  - Overall
    - TempWorks has applied the remaining 2024 state FUTA final rates and recalculations for Connecticut and the Virgin Islands as part of the year-end tax updates.
  - Maine
    - Completed 2025 withholding updates based on the requirements provided by the state of Maine.

- New Mexico
  - Completed Sales Tax updates for 2025 based on the requirements provided by the state of New

    Mexico
- Ohio
  - Completed Sales Tax updates for 2025 based on the requirements provided by the state of Ohio.
  - For Bainbridge Twp. Aurora JEDD, OH Added a new tax with a rate of 2.0%.
  - For New Corcord, OH Will be collected by RITA in 2025.
  - For Waynesfield, OH Will be collected by RITA in 2025.
- Pennsylvania
  - For Aldan, PA Added a new juris with a resident rate of 1.0% and a nonresident rate of 1.0%.
  - For Easttown Twp, PA Added a new juris with a resident rate of 0.5% and a nonresident rate of 0.5%.
  - For Ridley Park Boro, PA Added a new juris with a resident rate of 1.0% and a nonresident rate
     of 1.0%
  - For Upper Providence Twp, PA Added a new juris with a resident rate of 1.0% and a nonresident rate of 1.0%.
- Utah
  - Increased the Unemployment Wage Base to \$48,900 for 2025.
- Washington
  - Completed Sales Tax updates for 2025 based on the requirements provided by the state of Washington.

\*Note\* This release includes FUTA updates for Connecticut and US Virgin Islands. You should expect Dacpac updates to take longer than usual (by up to four hours) if you do business in these states.

Just a reminder that Dacpac updates often vary considerably in their execution time. Sometimes they may complete within ten minutes but occasionally require several hours to perform updates to the TempWorks database. Please plan accordingly for updating your systems to avoid impacting the availability of your TempWorks services.
