

# WebCenter - Enhanced Customer Portal - Inline Grid Editing

Inline grid editing for timecards allows you to:

- Click directly into a time entry cell
- Edit hours without navigating away from the grid
- Save updates immediately for each row
- Move through cells smoothly using tab or arrows for faster entry
